The applicant agrees to indemnify, hold harmless, and defend the Village of Niles and its officers, agents and employees, from any claims for all damages for which the Village of Niles or its officers, agents or employees may be held liable in a civil proceeding in law or equity as a result of any claim, including but not limited to negligence or resulting from the acts or omissions of any officer, agent or employee of the Village of Niles during the duration of the special event applied for in the Village of Niles.

The applicant understands and agrees that all electrical and wiring equipment, rides and structures must pass Village inspection before opening. All food vendors must complete a Temporary Food Permit application (3 weeks in advance) and pass inspection before opening. Permit and inspection fees may apply.

The Niles Police Department has the right to require security guards or special police. The Niles Fire Department has the right to require adequate fire lanes and emergency exits. The Police Chief or Fire Chief can shut down the event at any time if necessary to ensure public safety.
